MADAM NAGASUNDRAM NADARAJAH EDUCATION FUND

1. Objective of the Trust

- 1.1 The above Education Fund is to be used for the purpose of granting a loan to pursue a course in medicine in any of the Local Universities as follows:
 - 1.1.1 Universiti Malaya
 - 1.1.2 Universiti Kebangsaaan Malaysia
 - 1.1.3 Universiti Sains Malaysia
 - 1.1.4 Any other locally incorporated Universities established from time to tome.

2. <u>Eligibility for the Education Fund</u>

- 2.1 Eligibility for the loan from this Education Fund shall be confined to the following:
 - 2.1.1 Members who had continuously been in membership of the Koperasi Jaffnese Bhd for a period of 3 years at the time of application.
 - 2.1.2 Children of members whose membership with KJB has been for a continuous period of 5 years at the time of application.
 - 2.1.3 Children of any past member or guardian deceased while in membership (excluding children of those who has left or had been expelled from the Society) whose membership with the Society had been for a continues period of 5 years proceeding the event.

3. Agreement

- 3.1 Any advance disbursement shall be subject to the execution of an agreement as prescribed by the Society.
- 3.2 The applicant shall provide 2 guarantors who are members of the Society and whose individual monthly income is not less than RM1,500/-.

4. Other Information

- 4.1 The borrower to pay a minimum of RM50/- as subscription until full settlement of the loan.
- 4.2 The following document should accompany the application form:
 - 4.2.1 Admission letter from the University/College stating the nature of course and the period of study.
 - 4.2.2 Copy of receipts paid towards admission
 - 4.2.3 A copy of NRIC of student.
- 4.3 The total amount disbursed shall not exceed RM4,000 per academic year.
- 4.4 The first progress payment shall be released on execution of the agreement and on settling the processing and stamp fees.
