APPLICATION FORM FOR THE PARAMANANTHAM-SUBRAMANIAM-VYALADCHY MARRIAGE INCENTIVE AWARD

2. The number of applicants shall be limited to the **first 25 members** who submit their applications before the **31st of December** in each year. The applications exceeding the first 25 applications shall be carried forward to be considered in the following year.
3. The member should be **marrying** for the **first time** and the application should be submitted **within the current year of the award with the marriage being registered in the same year**.
4. A **copy of the marriage registration certificate** issued by the Registrar of Marriages, Malaysia for the **current year of the award duly certified by a Member of the Board or a District Chairperson**, should be **submitted** with the application form.
5. If the **couple marrying are both members**, they can **apply** for the award on the **same application form**.
6. The **quantum of the award** for each year shall be **decided by the Board** based on the number of applications received and the amount available for distribution but it shall not be less than **RM150.00**.
7. The award payments shall be disbursed in the month of **March** in each year
